- 3 Pro-rated LST levy withheld per full-time employee should equal \$7.50 per quarter for a total of \$30.00 per person per calendar year.
- ώ In the event a new full-time employee is hired during the quarter, the \$30.00 LST levy should be pro-rated by the number of remaining pay cycles through December 31.
- 4 In the event a part time employee reaches the \$12,000 threshold, the employer is to withhold a lump sum equal to what full time employees have had withheld up to that point in the year and then continue with pay period withholdings for the rest of the year.
- O In the event an employee is terminated during the quarter, please remit the current amount collected through the termination date.
