The meeting commenced at 7:02 p.m. with roll call and salute to the flag. All Board members were present with the exception of Member Rocco who had a work commitment this evening. Also present were Township Manager Peter Gray, Township Solicitor Lauren Gallagher, and Township Engineer James Sullivan.

## PRESENTATION BY RICHARD DIPPOLITO REGARDING THE FIRE MARSHAL'S DEPARTMENT

Fire Marshal Rich Dippolito said October is Fire Prevention Month. Fire Prevention week is this week and local fire departments will host open houses as follows: Fairless Hills Fire Department is Thursday, October 8<sup>th</sup> from 6:30 – 8:30 p.m.; Falls Fire Company is Saturday, October 10<sup>th</sup> from 10 a.m. – 1 p.m.; and Levittown Fire Co. No. 1 is Sunday, October 11<sup>th</sup> from 10 a.m. – 1 p.m. This year's theme is "Hear the beep where you sleep: Every bedroom needs a working smoke alarm." The fire marshal's office has two full-time inspectors and one part-time inspector. If any resident needs help installing a smoke detector or changing batteries, they should contact the fire marshal's office. The fire marshal's office checks township businesses in an effort to keep everyone safe in the work place. To date they have performed about 800 inspections. ## ITEM # 2 CERTIFICATE OF APPROPRIATENESS – 53 OLD LOCUST AVENUE – TMP # 13-032-044 – INSTALL 6' RED CEDAR FENCE ALONG THE SIDE OF THE PROPERTY

Member Boraski moved to approve the Certificate of Appropriateness for 53 Old Locust Avenue – TMP # 13-032-044 to install a 6' red cedar fence along the side of the property; Member Dence seconded the motion; all board members were in favor. (4-0)

# ITEM # 3 CONSIDER ADOPTING ORDINANCE AMENDING CHAPTER 209, SECTION 7, TO AMEND THE ZONING MAP, BY REZONING CERTAIN LANDS IDENTIFIED AT TMP # 13-020-306 FROM NCR – NEIGHBORHOOD CONSERVATION RESIDENTIAL DISTRICT TO IN – INSTITUTIONAL DISTRICT

Chairman Harvie introduced this item. The property to be rezoned is owned by the Walsh family. Mr. Thomas Hecker, who represents the applicant, said this parcel is about 1 acre. Mr. Hecker gave a brief description of the property and intended use for this parcel. There will be townhouses and two apartment buildings. This is an age-restricted community. Member Galloway moved to approve Ordinance # 15-7, amending Chapter 209, Section 7, to amend the Zoning Map, by rezoning certain lands identified at TMP # 13-020-306 from NCR – Neighborhood Conservation Residential District to IN – Institutional District; Member Dence seconded the motion; all board members were in favor with the exception of Member Boraski who voted no. (3-1)

# ITEM # 4 CONSIDER AUTHORIZATION FOR ADVERTISEMENT FOR EXTERIOR PAINTING AT THE THREE ARCHES HISTORICAL BUILDING

The board had a discussion about work needed at the Three Arches historical building and how they wish to proceed with this project. Mr. Brian Andrews was present for the discussion. The board spoke about a proposal from Mr. Wesley Sessa from 18th Century Restorations, Inc. Mr. Sessa was available to answer questions. Ms. Gallagher said the sump pump repair would need to be pulled out of this proposal as well as the painting. Mr. Boraski said this is a lot of money. He believes this should go out to bid to see if we can get any other bids to compare this to. Member Dence said he knows some of the history of this. There is work that has needed to be done for quite some time and finding someone who is certified to do this type of work is very difficult. Member Dence said Mr. Sessa walked through the building and then provided us with a menu of repairs and preventative maintenance items. There is a lot of upkeep involved. There was a local guy who did the roof, but he is not able to do any further work. As far as the price, we have nothing to compare this work to. Member Dence said we can put this out to bid, but he doesn't know if anyone will respond. Ms. Gallagher spoke about the Responsible Contractor Ordinance (RCO) which is triggered any time you spend \$10,000 or more on a project. Ms. Gallagher said the work that is listed requires a certain level of expertise. Once this goes out to bid, you have to award the contract to the lowest responsible bidder. Mr. Sullivan said they have to be able to show that they have done projects in a similar nature or include certain specifications. Mr. Sessa said he is aware of the necessary protocol. When he attends a prebid meeting, it is because he has already met the criteria of certain traits. He is required to list the artesian employee, the jobs he has worked on, the architect has to approve them, and they don't even make it to the pre-bid meeting unless they meet the guidelines. Member Boraski asked about the price increase. Manager Gray said the price went from \$71,000 to \$92,000 and is due to prevailing wages. Ms. Gallagher said instead of going out to bid you

can do a request for proposal for historical work. Member Dence moved to approve authorization to advertise for exterior painting at the Three Arches historical building; Member Boraski seconded the motion; all board members were in favor. (4-0)

Member Boraski moved to authorize Ms. Gallagher and Mr. Sullivan to work to put together a request for proposal for the Three Arches historical building; Member Galloway seconded the motion; all board members were in favor. (4-0)

# TEM # 6 CONSIDER PROPOSAL FROM BOUNDLESS TRAINING & CANINE PET SERVICES FOR DOG TRAINING IN THE FALLS TOWNSHIP COMMUNITY PARK

Ms. Katie Brennan, from Boundless Training & Canine Pet Services, submitted a proposal that would allow her to utilize the community park for her business of training dogs. All dogs will be leashed and they will not use the dog park for the training. There will be an 80/20 split between Ms. Brennan's business and the township. Member Dence moved to approve the proposal from Boundless Training & Canine Pet Service for dog training in the Falls Township Community Park subject to finalization with the solicitor's office; Member Galloway seconded the motion; all board members were in favor.
