ITEM # 2 CONSIDERATION OF RESCISSION OF REJECTION OF ALL BIDS FOR MUNICIPAL COMPLEX RENOVATIONS

Chairman Dence said at the last meeting we rejected all bids for the Municipal Complex. There was some confusion with the bid bonds and we discovered someone handling this process was in error. The bid bonds were posted via the PennBid website. Our decision now is we will un-reject the bids. Ms. Gallagher said we are rescinding the decision to reject the bids and we have secured agreements from most of the bidders to extend their bids because once they were rejected, they were no longer any good. Member Galloway moved to rescind the rejection of all bids for Municipal Complex Renovations; Member Mullen seconded the motion; all board members were in favor. (4-0)

Member Galloway moved to approve the intent to award the General Construction Contract for Municipal Complex Renovations to Rycon Construction in the amount of \$19,230,000; Member Mullen seconded the motion; all board members were in favor. (4-0)

Member Galloway moved to approve the intent to award the Electrical Construction Contract for Municipal Complex Renovations to the Farfield Company in the amount of \$3,749,000 which includes the fire alarm alternate in the amount of \$205,000; Member Mullen seconded the motion; all board members were in favor.
