

## PART 1.

### BUILDING PERMIT FEES

#### NOTE



**PERMIT FEES ARE DOUBLED IF RESPONSIBLE PARTY FAILS TO OBTAIN REQUIRED PERMITS PRIOR TO COMMENCING CONSTRUCTION, BUILDING AND/OR WORK AND IS THEREAFTER FORCED TO TAKE OUT PERMITS**

#### UCC CHARGE

The Commonwealth of Pennsylvania has mandated a surcharge of **\$4.50** for each permit issued under the Uniform Construction Code (UCC).

#### PLAN REVIEW FEES

**Residential Work – \$25.00**

**Commercial and Industrial New Construction, Additions, and Alterations – \$100.00**  
for each code review required (Building, Plumbing, Mechanical, Electrical and Fire)

#### RESIDENTIAL, NEW CONSTRUCTION, ADDITIONS AND ALTERATIONS

- **\$100.00** for the first **\$1,000.00** of the estimated cost of the work.
- Thereafter, **\$32.00** per thousand up to **\$20,000.00**.
- **\$12.00** per thousand or fraction over **\$20,000.00**
- Renewals or extensions on permits, the fee is **\$100.00** per calendar year.

#### Residential Decks

- Building permit fee shall be based upon the estimated square footage of the project and be charged at a rate of **\$0.50** per square foot.

#### Replacement of existing Pool Enclosure

- Building permit fee shall be a flat fee of **\$100.00**.

#### Residential Public Sidewalks

- Building permit fee shall be a flat fee of **\$50.00** which includes the UCC charge.  
**(See Part 11: Engineer's Fees)**

#### COMMERCIAL AND INDUSTRIAL – NEW CONSTRUCTION, ADDITIONS AND ALTERATIONS (STRUCTURAL, FIRE ALARMS, SPRINKLER SYSTEMS)

- **\$110.00** per thousand or fraction thereof of the estimated cost of the work for the first **\$50,000.00** of work.
- **\$22.00** per **\$1,000.00** or fraction thereof for the next **\$100,000.00**.
- **\$11.00** per thousand or fraction past **\$150,000.00**.

#### Reduction in Building Permit fees for installation of Alternative Energy Technology

- The fee for a building permit for the installation of an alternative energy source (solar, wind, etc.) shall be reduced by **75%** for any residential, commercial or industrial project.
- The alternative energy reduction shall only apply to that portion of the project that relates to the actual installation of the alternative energy source, not the project as a whole.

### **Milling, Re-paving and/or Re-striping of Commercial and Industrial Parking Lots**

- An Earth Disturbance Permit shall be required if milling exceeds two (2) inches in depth.
- For milling that is less than two (2) inches in depth, permit fees are \$50.00 per thousand or fraction thereof of the estimated cost of work, up to a maximum permit fee of \$2,000.00.

### **PLUMBING PERMIT FEES**

#### **Single Family Residential/ Multiple Owners/Multi-Tenant/Commercial/Industrial**

##### **Building Supply**

- \$50.00 for the first 50 feet
- \$20.00 for each additional joint and appurtenance

##### **Building Sewer**

- \$50.00 for the first 50 feet
- \$20.00 for each additional joint and appurtenance

##### **New Construction/Additions/Alterations**

- \$25.00 per fixture

### **NOTE**



- Initial 50 foot length shall be from that portion of new pipe starting closest to the building drain and extending out away from the building.
- The building sewer fees shall be charged separately from fees for new construction and alterations/additions. The limit for determining the fixture count between the building sewer fees and fees for new construction/additions/alterations is the dividing line between the building sewer and the building drain.
- Fixtures to which the above schedule apply include but are not limited to those involving automatic dishwashers, clothes and/or laundry washers, hot water heaters, garbage grinders and/or disposal units, humidifiers, water softeners, floor drains, sewer/water connections and tanks requiring traps and/or vents.

#### **Permit Fees for the Installation, Conversion or Replacement of Heating Systems and/or Air Conditioning Systems, Heat Pumps & Tank Installation/Removal**

- \$85.00 for the first \$1,000.00 or fractional cost of the work.
- \$20.00 for each additional \$1,000.00 of cost or fractional part thereof.

### **NOTE**



- This includes, but is not limited to, commercial cooking hoods, wood stoves, metal fireplaces, gas stoves, logs and inserts. Masonry fireplaces will be charged under Building Permit fees.

- Plans for fire suppression and detection systems as required by the International Building Code will be reviewed and inspected by the Fire Marshal. The fees will be calculated using the formula designated under Part 1. Building Permit Fees.
- An additional fee of \$25.00 will be assessed for each month the permit has not been acquired.

**Annual Fire Prevention Permits:**

- The below permits shall be required annually in accordance with the Fire Prevention Code of Falls Township.
- Permits shall be valid for a one (1) year period from the date of issue.
- Initial permit applications submitted shall pay the annual fee listed without regard to when the application is made.
- Permit fees shall be paid at the time of application.
- Permit fees are **non-refundable** even if the application is rejected.
- A late fee of **25%** of the cost of the permit or **\$25.00**, whichever is greater, will be charged when permits are not acquired within the scheduled time after mail out.
- Re-inspection fees shall be charged at a rate of half the Annual Permit Fee for each failed or incomplete inspection unless previous arrangements have been made.
- All Assembly, Business, Educational, Factory, High-Hazard, Institutional, Storage, Mercantile and Residential R-1 and R-2 uses shall obtain a Fire Prevention Permit from the Office of the Fire Marshal as required by the 2009 International Building and Fire Codes as adopted and amended by the Township.

**Operational Permits**, as required by the International Fire Code, shall be \$60.00 each, except for the Manufacturing, Storing, Selling or Disposing of Explosives or Blasting Agents, which shall be \$500.00.

**Business License.** An annual business and professional license is hereby required for all persons conducting a commercial business or practicing a profession in Falls Township as further defined in the Falls Township Code, Chapter 145. The annual cost for each application submitted shall be \$75. A late fee of \$50 will be added if said business license application and the annual payment is not received by December 31 of the preceding applicable year.

**Limited Time and/or Temporary Permits – Per Day**

- Permits shall be for only that period specified on the permit.
- Permit fee shall not be refunded due to the failure of the applicant to undertake the activity specified on the permit.
- Requests for extensions of permits shall constitute a new application and all fees shall be paid for a new permit.

## **PART 10.**

### **SUBDIVISION AND LAND DEVELOPMENT SECURITY ACCOUNT**

- Money will be placed into Subdivision Security Account (SSA) for reimbursement at the Township's discretion, for any and all advertising, engineering, legal or other expenses incurred by the Township, exclusive of full time Township Staff Members in processing the preliminary and final plans or requests for rezoning.
- As soon as the SSA decreases to fifty percent (50%), the developer shall make payment in an amount necessary to restore the account to its original requirement.
- Upon the recording of the subdivision plan with the Recorder of Deeds, or upon final action by the Board of Supervisors on a land development plan or a request for rezoning, and the payment of all advertising, engineering, legal and other expenses incurred by the Township, exclusive of full time staff members, the balance of the SSA shall be refunded to the developer.
- Money held in the SSA will not be returned until all invoices from the Township have been paid by the developer.
- If during the course of the review process additional funds are needed to cover the review expenses of the Township, the applicant will deposit said funds with the Township.
