

ITEM #1: PLAN REVIEWS

Pennsbury High School Redevelopment 2nd resubmission.





Requested waivers include the following of interest:

- A waiver from SALDO §191-37(G)(1) which requires a maximum of 20 parking spaces in a row before an island is required. As an alternative to the islands at 20 parking space intervals, we are proposing 10 feet and 20 feet wide islands between each double loaded parking aisle. This provides more green space in the parking lot than the island requirement and allows trees to be distributed more regularly through the parking lot. The end caps on the parking isles are painted gore stripes. This layout facilitates snow plowing efforts. A waiver is requested to accept the parking lot island layout as depicted on the land development plans.
- A waiver from SALDO §191-37(G)(3) which gives the Supervisors the option to require tenfoot-wide islands between double-loaded rows of parking with a sidewalk, shade trees, and lighting. A partial waiver is requested as there are no islands in the bus maintenance or bus loading areas to allow for better bus access and parking in this location only. We are providing the ten-foot-wide island between rows of parking and lighting in the islands. Sidewalk is limited to ADA parking access sidewalk and a perpendicular access crossing the islands to provide a path for pedestrians to access the building. Landscaping is provided in most of the islands with the exception of the island closest to the building. Shade trees in these islands has been omitted to provide an unobscured view of the drop-off lane. A waiver is requested to accept the plan as submitted relative to parking lot island, sidewalks, lighting and shade trees.
- (NEW) A waiver from SALDO §191-48(D) which requires that trees be no closer than 30 feet from the intersection of the street right-of-way, including the drip line. We are requesting a

partial waiver to allow the drip line to be within the clear site triangle. A note has been added to the plan indicating that the area within the clear site triangle must be kept clear to an elevation of 10 feet. This waiver will allow existing trees to be preserved and buffer trees to be planted.

The Council has no major concerns at this time.
